The Sutter Buttes 4-H Scholarship is intended to honor high school seniors whose 4-H experience has not only made a significant impact on their lives, but also has benefited the 4-H program, particularly Sutter Buttes 4-H, and/or the community. Therefore the following criteria apply:

- Minimum of 2 years membership in the Sutter Buttes 4-H Club.
- Active participation in 4-H events and activities during their membership in particular participation and contribution to the Sutter Buttes 4-H Club.
- Demonstrated leadership and citizenship in the 4-H program and the community.

A scholarship committee will review all information submitted and determine the number of scholarships to be awarded each year (maximum 3). All applications will be reviewed and discussed equally. Those who have been selected will be notified at their appropriate high school awards ceremony.

The 2025 Sutter Buttes 4-H Scholarship will be awarded as First Place - \$750, Second Place - \$500 and Third Place \$300. Receiving the award is contingent on supplying proof of enrollment at an accredited school, college or university.

 - 4. Tell how this scholarship will help you achieve your future goals.
 - 5. You may attach a resume and/or summary page(s) of your Activities and Awards in 4-H, School, and in the community.
- Applicant must give a talk at the April 8, 2025 4-H Meeting describing their accomplishments, experiences and goals. (Not to exceed 5 minutes)

JUDGING CRITERIA FOR THE SUTTER BUTTES 4-H SCHOLARSHIP

The Sutter Buttes 4-H Scholarship is intended to honor high school seniors whose 4-H experience has not only made a significant impact on their lives, but also has benefited the 4-H program and/or community. Therefore the following criteria apply:

- Minimum of 2 years membership in the Sutter Buttes 4-H Club.
- Active participation in 4-H events and activities during their membership in particular participation and contribution to the Sutter Buttes 4-H Club.
- Demonstrated leadership and citizenship in the 4-H program and the community.

The Applicant must submit the following:

- Sutter Buttes 4-H Scholarship Application Form
- Letter of Recommendation from a 4-H Leader (Community, Project or Resource Leader)
- Letter of Recommendation from a Teacher
- Written Essay, not to exceed four pages, addressing the following:
 - 1. Describe your most significant leadership and citizenship experiences in 4-H, in school, and in the community.
 - 2. List your most significant honors, awards and recognition received in 4-H.
 - 3. Describe how your 4-H experiences have influenced your future goals.
 - 4. Tell how this scholarship will help you achieve your future goals.
- Resume or Summary Page(s) of Activities and Awards both in 4-H, school and the community.
- Give a short talk not to exceed 5 minutes at the April 4, 2023 Sutter Buttes 4-H Community Club Meeting describing their accomplishments, experiences and goals.

Judging of Applications

A committee of 4-H leaders and/or community adult volunteers, plus a minimum of one 4-H member, who is a current officer but not an applicant, will review the applications.

- A minimum of three (3) individuals will be on the committee.
- Applications will be reviewed for completeness and for meeting minimum criteria.
- Each application will be reviewed individually and evaluated based on how well it meets the requirements. Then the applications will be ranked to determine a 1st, 2nd and 3rd place winner.
- The committee will determine the scholarship winner(s) and their decision will be final.
- The committee can determine that no applicants or less than the designated 3 meet the requirements for that year.
- The committee may award a maximum of three (3) scholarships in any given year. In order to award more than three, and/or if additional funds are needed, they would need approval from the 4-H membership.

Evaluating the Criteria

Minimum of 2 years membership in Sutter Buttes 4-H: The committee chair will ensure that records are checked to make sure that the applicant meets the criteria.

Active participation in 4-H events and Activities: It is the expectation that the individual was a contributor during their time in 4-H. This would include, committees, offices, helping with activities, showing at the fair, demonstrations, etc. It is especially important that the 4-H participation be heavily weighted to events and activities that contributed to the advancement of Sutter Buttes 4-H. (40 points)

Demonstrated leadership/citizenship in the 4-H program and the community: It is the expectation that the individual demonstrated leadership and citizenship during their time in 4-H and perhaps in the community. This includes holding offices, committee chairs, junior or teen leader positions, helping with major events. It also includes community/school involvement that demonstrates leadership/citizenship by being actively involved in civic or community events, holding school offices, or leading school organizations. (30 points)

Letters of Recommendation: Letters should support the above criteria and give examples of the applicant's participation and their character. The letter should address accomplishments and involvement in 4-H, as well as in other activities at school or in the community. (10 points)

Talk to the 4-H Club/Written Essay: The talk should be no more than 5 minutes and should convey how the applicant's 4-H experiences, as well as school and community experiences have helped them to succeed. This is an opportunity for the current 4-H members to learn about the applicants, and for the applicants to express themselves verbally. The essay must be well-written and express specifically the applicants involvement in Sutter Buttes 4-H. (20 points)
